Guidance to Councillors and Co-opted Members of the Council to Complete the Register of Interests

1. **The form must be completed by you and returned to the Parish Clerk within 28 days of your election or appointment to office.**
2. You must also inform the Parish Clerk in writing of any change to the Register of your interests within 28 days of the change occurring.
3. If you fail to comply with 1. or 2. above, it will be a breach of the Council's Code of Conduct.
4. The headings to the form are provided for ease of reference and do not affect the interpretation of the paragraphs.
5. The completed form will be made available by the Council for inspection by the public.
6. You should ensure that you have a copy of the completed form so that you can check its contents when you are considering the agenda for a meeting you are attending and decide whether or not you need to declare a personal or prejudicial interest at the meeting.
7. Please complete the form in black ink by writing in capital letters, or by typing your responses.
8. Paragraph 4 of the form refers to a 'relevant authority'. These words are defined by the Local Government Act 2000 as having the following meaning:-A county council, a county borough council, a district council, a London borough council, a parish council, a community council, the Greater London Authority, the Metropolitan Police Authority, the London Fire and Emergency Planning Authority, the Common Council of the City of London in its capacity as a local authority or police authority, the Council of the Isles of Scilly, a fire and rescue authority constituted by a scheme under section 2 of the Fire and Rescue Services Act 2004 or a scheme to which section 4 of that Act applies, a police authority, a joint authority established by Part IV of the Local Government Act 1985, the Broads Authority, or a National Park authority established under section 63 of the Environment Act 1995.
